Blue Cross<sup>®</sup> Blue Shield<sup>®</sup> of Arizona (BCBSAZ) benefit plans exclude drugs that have been classified as obsolete or have not been approved by the FDA.



Pharmacy medications are classified as obsolete when they are no longer manufactured and are also at least two years past their shelf life.

## What to do when the ID card says Blue High Performance Network (BlueHPN)

BCBSAZ publishes a list of obsolete drug codes. These codes are not eligible for reimbursement.

#### Prepare now for the July 1 updates

Effective July 1, 2022, we will add 22 additional codes to the obsolete drug code list—below are some of these codes. You can avoid claim denials by updating your system and informing your clinical and billing staff of our complete list of obsolete pharmacy codes. This helpful resource includes links to CMS and the National Bureau of Economic Research that you can access to ensure you are using only current CPT<sup>®</sup>/HCPCS codes for the national drug codes on your claims.

J0400	INJECTION, ARIPIPRAZOLE, INTRAMUSCULAR, 0.25 MG	This form of Abilify <sup>®</sup> is no longer manufactured. Abilify Maintena <sup>®</sup> is billed under <b>J0401</b> .
Q2038	INFLUENZA VIRUS VACCINE SPLIT VIRUS, WHEN ADMIN TO INDIVIDUALS 3 YRS/> (FLUZONE)	Split virus forms of Fluzone are no longer manufactured. Other forms of Fluzone can be billed with <b>90662</b> (high-dose) or <b>90685/90686/90687/90688</b> (Fluzone Quadrivalent).
