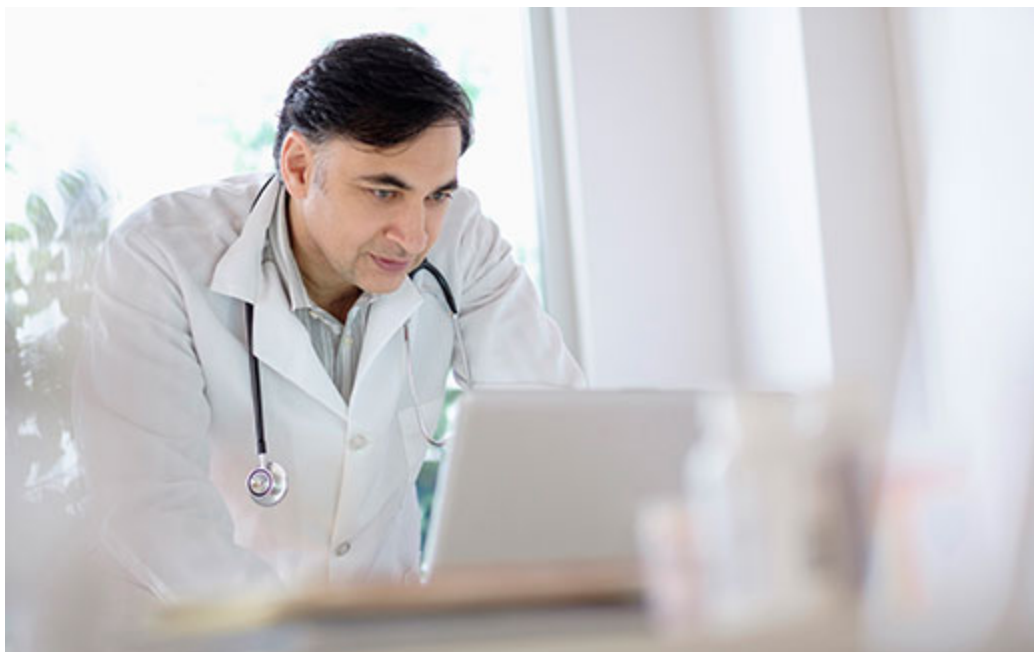

You can use Cover My Meds ePA for plans that use BCBSAZ for pharmacy benefit coverage. Look for our Rx BIN number **603017** on the member ID card. We manage pharmacy benefits for our individual plans and most of our group plans. However, some of our large, self-funded groups use a third-party PBM, as indicated on the back of the ID card. Other exclusions include:

- BlueCard® (out-of-area) plans—check the member ID card
- Corporate Health Services (CHS) group plans (these [network-rental plans](#) are administered by a third-party administrator [TPA])—check the member ID card
- Federal Employee Program® (FEP®) plans—CVS Caremark manages prior approval
- Medicare Advantage plans—MedImpact manages prior authorization for Part D drugs
- BCBSAZ-TPA co-administered plans—check the member ID card
